Phosphates are slowly and incompletely absorbed in the intestinal tract. The most frequently observed effect is gastrointestinal irritation with abdominal pain and cramping, vomiting, diarrhea. If ingestion of large doses occurs and if a significant amount of phosphate is absorbed, severe electrolyte (mineral) disturbances (imbalances) can occur resulting in hyperphosphatemia, hypocalcemia, hyperkalemia, hypernatremia and hypomagnesemia may occur. Symptoms may include anorexia, increased thirst (dehydration), metabolic acidosis, decrease in the amount of urine or in frequency of urination, renal failure, troubled breathing and shortness of breath, tetany/carpopedal spasms, seizures/convulsions, tremor, dizziness, fatigue, lethargy, confusion, changes in mood such as anxiety, depression or irritability, weakness, muscle cramps, numbness or tingling, pain around the mouth or lips, hands or feet, weakness in the hands or feet, bradycardia (slow heartbeat) or tachycardia (fast heartbeat), dysrhythmias (cardiac arrhythmias), hypotension, cardiac arrest, hyperpyrexia.
